


About Your Qualification


Understanding the E-Portfolio System

Step-by-Step Guide to Completing Your NVQ

Registration:

Complete the registration form sent via email

Awarding Body Enrolment:

Receive confirmation and login details.

3

Induction:

Schedule your induction with your assessor (typically within 48 hours).

4

Portal Familiarization:

Learn how to use the E-Portfolio system.

5

Knowledge Questions:

Begin uploading evidence and completing knowledge packs.

6

Assessment:

Participate in structured evaluations site evidence, professional discussions, witness testimony.

7

Portfolio Submission:

Your portfolio undergoes internal and external quality checks

8

Completion:

Receive your digital NVQ certificate

Evidence Collection and Submission

Evidence demonstrates your competency and should include, but not limited to

- Risk assessments and safety management plans
- Incident investigation reports and strategic audits
- Corporate safety policies and procedures
- Emails, meeting notes, and board-level documentation
- Witness testimonies from senior management

Ensure evidence is less than two years old, clearly labelled, and uploaded via the E-Portfolio system.



Assessment Methods in Detail

We employ diverse methods to validate your skills:

- **Projects documentation: Remote** evaluations of your site evidence and documents.
- **Knowledge questions:** Structured questions designed to reflect your knowledge and experience
- **Professional Discussions:** Structured conversations about your responsibilities.
- Witness Testimonies: Colleagues or supervisors provide recorded feedback.

Your assessor will recommend the most suitable methods.

Frequently Asked Questions

Q: How long will my NVQ take?

A: While most learners complete their NVQ in 8–12 weeks, timelines can be adjusted.

Q: Can I switch optional units midway?

A: Yes, discuss this with your assessor for guidance.

Q: What happens if I exceed one year?

A: Extensions are possible, but additional fees may apply.
